Sub: Affiliated Colleges (Autonomous / Non- Autonomous) / Special provision made for Ph.D. guideship - Indian and Foreign Languages - Syndicate Resolution dated 03-05-2019 - Reg.

I am by direction to inform you that to consider the Teachers teaching Foundation courses in Indian and Foreign Languages in Affiliated Colleges an opportunity has been provided by the Syndicate at its meeting held on 03-05-2019 and resolved as follows:

RESOLVED that the following addition / modification in the existing University Ph.D. Regulation 2018 be approved and implemented with immediate effect in order to increase the availability of qualified teachers in the Indian and foreign Languages and the same be placed in the Academic Council and Senate for ratification.

6.1 (c) Full time regular faculty members teaching Under-graduate / Foundation Courses in Indian Languages namely Telugu, Malayalam, Kannada, Sanskrit, Hindi and Urdu and Foreign Languages like French , German and Chinese can act as Ph.D. supervisor even though the Department of Affiliated Colleges is not recognized to offer Ph.D. programme. This provision is valid only for two academic years (2019-2020 and 2020-2021).

Hence, this provision may kindly circulate to the faculty members of your Department / Colleges for the benefit of teachers teaching Foundation courses in Indian and Foreign Languages.
